# TR50 5-in-1 Sensor Giveaway

## OFFICIAL RULES

**1. Promotion Description:** The Honeywell TR50 5-in-1 Sensor Giveaway Promotion (the "Promotion") begins on June 1, 2023 at 12:00 am CST and ends on June 30, 2023 at 11:59PM CST (the "Promotion Period"). The sponsor of this Promotion is Honeywell International Inc. (the "Sponsor"). By participating in the Promotion, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, which shall be final and binding in all respects. Sponsor is responsible for the collection, submission or processing of entries and the overall administration of the Promotion. **4. Prizes:** One winner will receive up to five TR50 5-in-1 Sensors (tr50-5d) needed to complete their installation (approximate retail value ("ARV") of \$6,675USD). Installation must be completed by an approved Honeywell WEBS contractor: [https://buildingcontrols.honeywell.com/contractor\\_search](https://buildingcontrols.honeywell.com/contractor_search). Actual/appraised value may differ at time of prize award. The specifics of the prize shall be solely determined by the Sponsor.

Prizes cannot be transferred, redeemed for cash, or substituted by winner.
